# History

In February 2010, the National Telecommunications and Information Administration (NTIA) awarded KINBER, a new nonprofit corporation, a \$99.6 million grant for the implementation and management of a middle-mile network called PennREN. KINBER will oversee the completion of PennREN, a network comprised of 1,600 miles of fiber and network equipment delivering services to locations throughout the Commonwealth of Pennsylvania for use by community anchor institutions including universities, colleges, K-12 schools, libraries, public media organizations, and healthcare organizations, among others. PennREN will provide these institutions with competitively priced, networking services that will enhance the opportunities for collaboration and economies of scale for network transport, transit, and connectivity.


